

# **Volunteer Opportunity – IGBA Sustainable Transit Technical Advisory Group**

**Title:** Technical Advisory Group Expert Member

**Based:** Remotely and/or Locally

#### **Purpose:**

The Sustainable Transit Technical Advisory Group (TAG) will review the IGBA green business checklist standards and make additions, and revisions to all standards in the transportation section based on local and national trends affecting businesses.

### **Responsibilities:**

- 1) Provide expertise on the IGBA green business checklist standards and certification program.
- 2) Research cutting edge strategies and technologies that can be implemented into the transportation section.
- 3) Develop methods and actively implement new standards into the transportation section of the IGBA green business certification program checklist.
- 4) Closely collaborate and coordinate with other Technical Advisory Groups, IGBA Staff and the Certification Steering Committee to provide synergistic strategies and holistic solutions to barriers and difficulties in green business practices and standards.

## **Qualifications & Criteria:**

The Technical Advisory Group Experts will be a national collection of technical experts encompassing areas of community outreach, energy conservation, landscape design, pollution prevention, sustainable purchasing, sustainable transit, waste reduction, and water conservation. Ideal candidates will have deep expertise in areas listed below and a direct understanding of how to address the emissions associated with the strategies and solutions for large scale developments.

Sustainable Transit Technical Advisory Group Expert Candidates will ideally have:

- 1) Minimum of 5-7 years of direct and recent project experience in one or more areas from the following:
  - a. Public transit advocacy
  - b. Alternative transport (bicycle, car sharing, electric vehicles)
  - c. Public transit vehicle maintenance & support
  - d. Mass transit planning & program development
- 2) Employment and/or organizational support with a related/relevant organization throughout the period of gained experience.



### **Time Expectations:**

Technical Advisory Group Experts will be expected to give an average of 3-5 hours of their time each month. Time commitment may vary month to month.

Members will serve two year commitments, renewable on an annual basis upon mutual consent.
