Dear Colleagues,

I am pleased to continue the charge of the Sustainability Council for the next year and appreciate that this group represents the highest level of evaluation of sustainability policies and initiatives for the campus. I am writing to ask you to serve on the Council, which supports the campus in meeting the targets set in the Illinois Climate Action Plan (iCAP). This group will help create an updated five-year plan for the iCAP in 2026, in consultation with key stakeholders and as we carry out campus strategic planning. I will chair my first Sustainability Council meeting on December 3, 2025, from 3:30-5:00 p.m. and would very much look forward to your participation.

As many of you know, the campus has embraced sustainability action following the results of the Visioning Future Excellence process and the creation of the Institute for Sustainability, Energy, and the Environment (iSEE). In signing the Second Nature Resilience Commitment in February 2016, the university pledged to identify and explore areas where campus operations are

vulnerable to changes in climate. Combined with the 2008 American College & University Presidents' Climate Commitment (now known as the Second Nature Carbon Commitment), the Urbana-Champaign campus is a charter signatory of Second Nature's full Climate Commitment.

To renew the iCAP, the Council will play an important role in evaluating measures that have major impacts on campus budget or policy. A high-level review of these recommendations will be presented at the upcoming Council meeting, and I will greatly appreciate your feedback. You can expect to hear about proposals for the iCAP 2026 that contain 41 SMART (specific, measurable, achievable, relevant, and time-based) objectives organized into eight key themes: Energy, Transportation, Land & Water, Zero Waste, Sustainable Buildings, Education, and Engagement.

In devoting attention and resources to implementing these commitments, we reaffirm our pledge to become carbon neutral as soon as possible and to support the continued excellence of the University of Illinois Urbana-Champaign long into the future. This campus will continue to serve as a model of sustainability for all universities in the nation.
