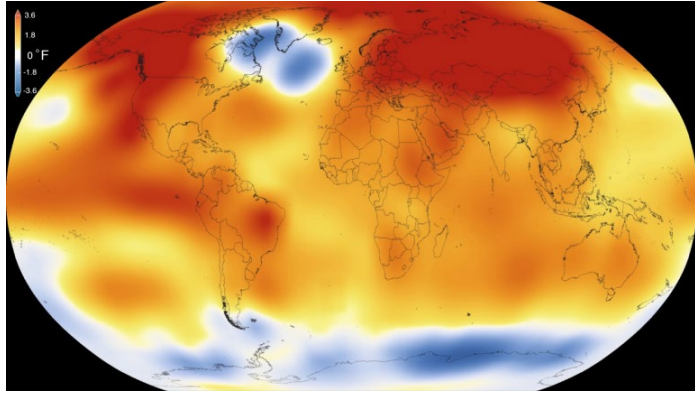

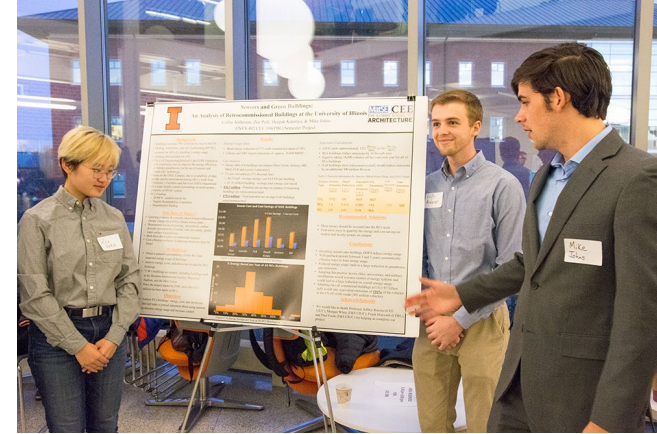

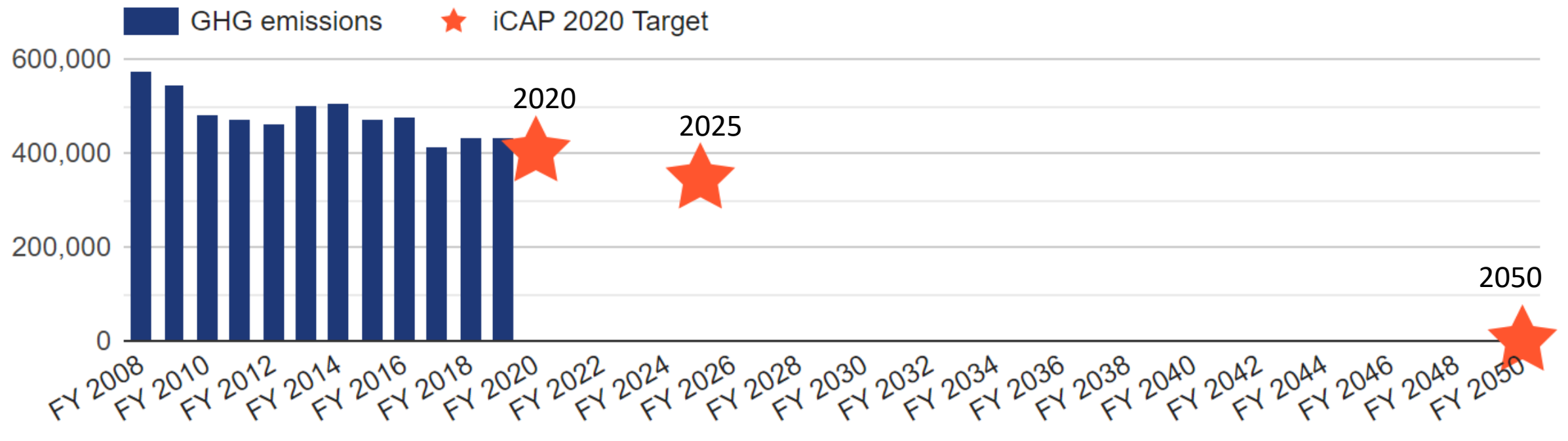


Education & outreach

The overarching goal: To become a global model of sustainability by creating effective, positive change. Also, to become the “front porch” for all sorts of sustainability resources for campus and community members.

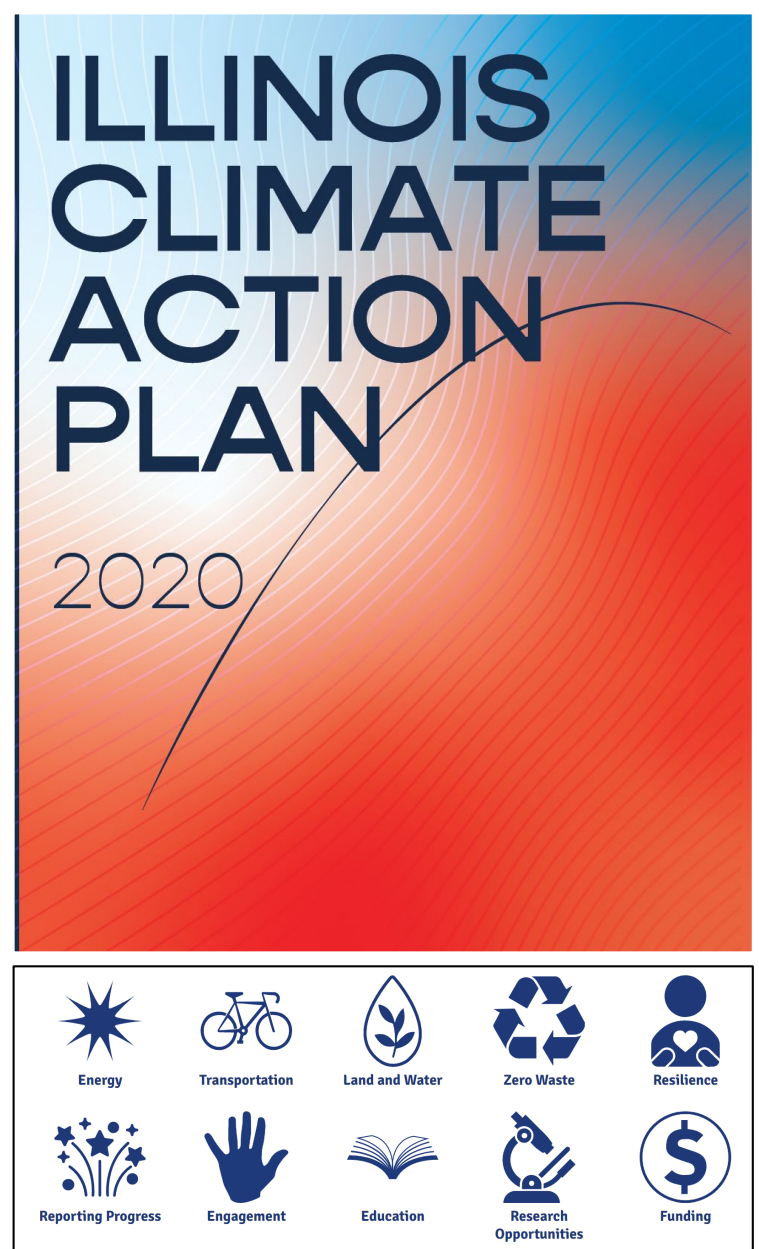


Total Campus Greenhouse Gas Emissions

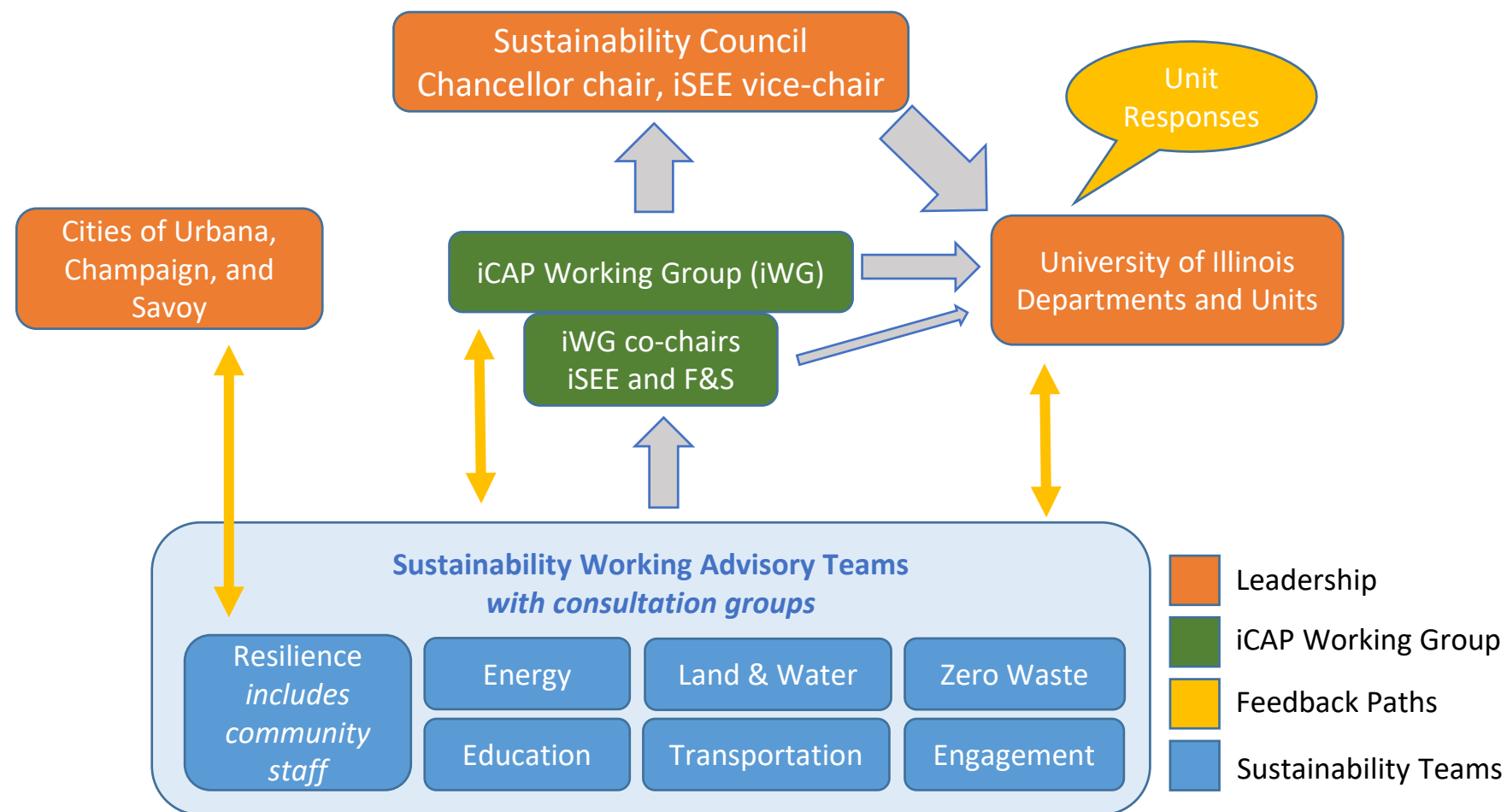


Illinois Climate Action Plan

- Breaking down the walls of tradition to help create meaningful and transformative changes

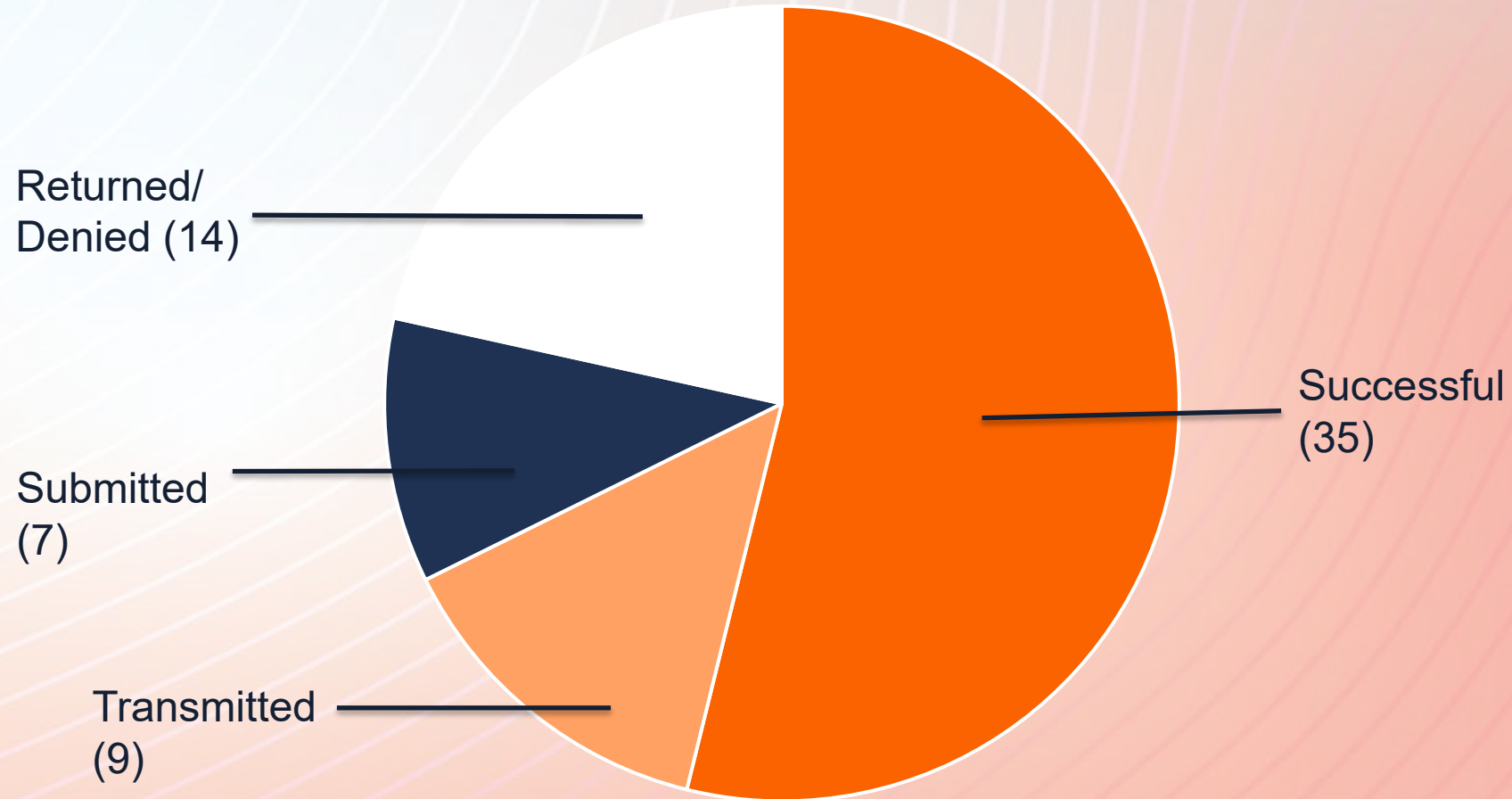

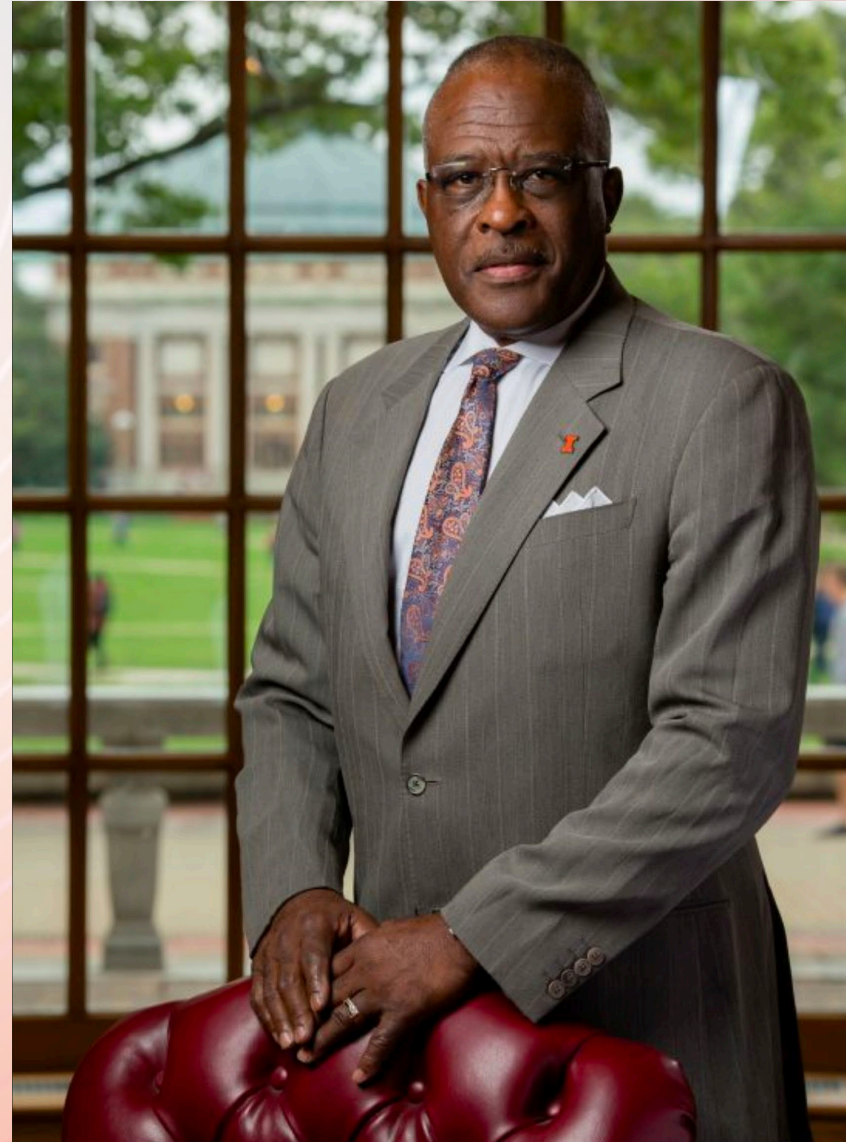
