

- South Bronx experienced a loss of investment , which led to environmental degradation
- Worked to implement sustainable programs into the South Bronx because she experienced the effects of financial neglect and environmental racism
- Founded Sustainable South Bronx, which promotes green job training to improve state of South Bronx

01

Intersection of environmental justice and urban redevelopment

- Poverty and rates of crime can decrease with the implementation with greener infrastructure + improved urban policies
- Impact of flawed urban policy
 - Consider the Colombian example of improved transportation infrastructure

What does Carter mean by her definition of “environmental justice”? How does that connect with what she means when she says residents of environmental justice communities are the “canary in the coal mine”?

Carter contends that “race and class are extremely reliable indicators as to where one might find the good stuff [in a community], like parks and trees, and where one might find the bad stuff, like power plants and waste facilities.” How does Carter’s statement reflect the C-U area? Discuss where you usually see the “bad stuff” as well as the “good stuff”?

5th & Hill

The 3.5 acre lot at 5th Street and Hill Street in Champaign is a former manufactured gas plant (FMGP) site from 1887 until 1953. Gas was manufactured by heating coal, and then following a process to remove coal tar and other impurities. The coal tar and other production wastes were left on the site until the closing of the plant.

According to information provided by Illinois Power (now Ameren IP) in 1990, the lightweight chemical compounds found in coal tar, known as BTEX (benzene, toluene, ethylbenzene, and xylene), move easily through soils and are associated with various health problems.
