
Deliveries during the holiday season are always important, and this year SmartWay extends a special greeting of gratitude to its Partners and the entire freight community. 2021 was another challenging

### EPA Gives Overview, Seeks Input on Clean School Bus Program 2021 Bipartisan Infrastructure Law includes \$5 Billion in Appropriations

On December 15, EPA hosted a listening session covering the 2021 Bipartisan Infrastructure Law and its \$5 billion investment in the nation's fleet of K-12



school buses. Presentations and a recording of the session will be available late in December on the Clean School Bus website <u>here</u>. Under the recently enacted legislation, EPA will offer a total of \$5 billion between fiscal years 2022 and 2026 to fund the replacement of existing school buses with low- or zero-emission school buses.
