- USGBC is interested in purchasing a small amount (~500 credits) to help offset their GreenBuild event. They would also highlight the projects in communications. Its a minimal volume for us, but I think its a really great opportunity to get visibility for these projects and the C2P2 program.

- The price point for these is the same as our last sale to BPTN. **Please let me know ASAP if you would NOT like to be included in these potential sales.**

We'll be reconnecting with BPTN in October, and are hoping they will continue to support these projects with a large-volume sale. I'll keep everyone updated in the meantime, and will also set up a group call to check in once the semesters are underway.

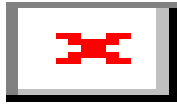

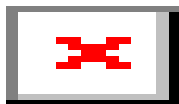
