Hello Helen and Evan,

Per the attached MOU, the two of you are responsible for evaluating and approving the use of Carbon Credit sales funding. My understanding of our current funding level is in my previous email, showing approximately \$600K available to allocate.

Please approve: Campus Tree Inventory, estimated at \$50,000

The Campus Tree Advisory Committee and the Agriculture, Land Use, Food, and Sequestration SWATeam are seeking funding for an update to the Campus Tree Inventory (see attached). This is in support of the iCAP objective 7.2 "Design and maintain campus landscapes in a more sustainable manner; expand the specification of sustainable plantings in campus landscaping standards, develop and implement a tree care plan by FY16 and an integrated pest management program by FY17," or more specifically, in support of the Tree Care Plan.

Per the CC Sales MOU, the SWATeams can propose projects using these funds. Typically, I would prefer to have the iCAP Working Group assessment complete before sharing the funding request with the two of you, but I believe it will be more convenient for you to consider these two requests concurrently. Thus, I am forwarding this without the iWG review.
