

# The Southeast Side of Chicago has been a "sacrifice zone" for years



- The Koch brothers & other industrial manufacturing companies have used the Southeast Side as a dumping ground for petroleum coke.
- With the discovery of toxic levels of manganese from the SH Bell facility in the air and soil, community members are in even more imminent danger.
- This is, unfortunately, one of many polluters that have operations set up in the Southeast Side of Chicago.



### **HOW DID THIS HAPPEN?**

- Governmental Policy failure, community members left in the dark about polluters in their neighborhoods
  - Inadequate monitoring and inspections
  - Little investment into health-based research on residential exposure and biomarkers
  - Zoning Policy failure, there are often zoning regulations that favors corporate interests over environmental justice and community safety
