## **BPAC Bylaws**

as specified in Urbana City Code Sections 23-148 and 23-150

Article II

## Responsibilities of the Commission

The purposes of the Commission shall be to:

- 1. Advise the City Council on bicyclist and pedestrian issues;
- 2. Analyze routing, operation and safety of bicycles;
- Review and make recommendations regarding the City's Capital Improvement Plan and Bicycle Master Plan;
- Evaluate and make recommendations for an action plan for biking and walking facilities (on- street and off-street paths and lanes, bicycle racks, signage and signalization);
- 5. Coordinate with external agencies on maps and regional path connections;
- 6. Develop education and public outreach programs on bicycle and pedestrian issues;
- Assist the City in the development of bicycle and pedestrian systems within the community; and
- 8. Perform such further duties as may be delegated to it by the Mayor and City Council.

The Commission shall advise and consult with the Mayor and City Council on the issues set forth in Article II and recommend such actions to them as it deems appropriate to effectuate the intent of these bylaws.
