#### I. Status of Action Items

# A. Housing Recycling

- Recyclopedia: Information on proper recycling activities, could use to create marketing and informatics to implement campuswide.
  - [Miriam] Place QR code/flier in new student bags and throughout residence halls.
- Building Service Worker Training: Refresher presentation on recycling and sorting guidelines.

### B. Education & Engagement Team Updates

- Engagement: Brainstorming survey questions, discussion on bringing more volunteer engagement to recycling events.
- [Daphne]: Chairs of each team will begin to meet monthly to facilitate more collaboration.
- C. <u>Green Sports Alliance:</u> We have paid for membership, Tim suggests looking into online workshops that are free and which are most beneficial.

#### D. Environmentally Preferable Procurement

- AASHE: 2024 Sustainability Change Leadership Program, global cohort to build sustainability in campus environments. Daphne is working with this, and is focused on applying our EPP goals.
- E. <u>Coca-Cola Buy Back:</u> Current strategies include Coke Freestyle machines (UIUC currently uses, but does not push with reusable bottles). OSU had very little success here, finding it cost prohibitive.
  - Reverse Vending Machines (article in Box): Past funding by Coke was
    offered, but push-back was found at the F&S level. Joy thinks this is
    something worth looking into.
  - [Daphne] We are unsure if these plastics and aluminums ever make it back to Coca-Cola.

- A. <u>EPA Grant Opportunity:</u> IRA Community Change Grants Program, community based non-profit. Partnering with city and waste stewards to create a project idea.

  - Working to gain a solid volunteer base. Updates from Engagement TBA.
- C. <u>SB1555</u>: Packaging and Paper Products Stewardship Act
  - Illinois Statewide Recycling Needs Assessment Advisory Council established.

- A. <u>Ongoing CHARGE objectives:</u> drafting hydration station standards, designing a volunteer program for recycling events, developing sustainable policy for vendor contracts, waste reduction program for residence halls, recommendations for new bins, Green Cleaning Program.
  - [Miriam] Reach out to student organizations and Greek life that require service hours.
  - [Daphne] Grounds for the food waste reduction program exist so we could build on that. Increasing information about waste disposal in residence halls.
  - Most important goal for this semester: meet with stakeholders to prepare for recommendation writing. Potentially will be inquiring with the iCAP working group to propose recommendations before writing them.
