

Currently, Bicycle Programming and Infrastructure Fee (Bike Fee) is only \$1 per student per semester, which amounts to about \$90,000 per year. I am very grateful for the Bike Fee, however, we cannot budget for intern(s) with that funding. I am requesting the SSC to allocate \$44,880 to hire at least one student intern for the Sustainable Transportation projects. This funding would allow us to have interns for the next two years, and hopefully the Bike Fee may increase which would allow for intern budgets using bike fee.

- The student interns would support several sustainable transportation projects on campus, including but not limited to:

 Help with designing and reviewing, as well help with managing the construction (when needed) for bicycle and pedestrian related projects
- Eco-Counters for monthly data collect for all counters (24 locations on campus so far). The student interns will also analyze the data and create reports for us to see for all the corridors. Students may be involved with procuring more counters, if
- EV charging stations F&S is installing several charging stations for F&S fleet and the Parking department manages the EV charging stations for public use. The student intern would analyze the data.
- Supporting sidewalk improvement projects and ADA compliance projects
- GIS support for bicycle infrastructure on campus
- Bike repair stations
 Abandoned bicycles project
- Education campaigns to promote active modes of transportation, including tabling events, digital signs, social media posts, etc.
 Supporting the iCAP Portal for transportation related project updates
- Helping with future SSC projects and reports
- Supporting other sustainability related projects, if needed and if the student shows interest in that topic.
