Describe your project in detail. *



Our project is a collaboration between the Office of Diversity, Social Justice Education and the Native American House to have Tara Houska speak at each of our respective events. Tara Houska is a tribal land attorney who has dedicated her life's work to sustainability and environmental justice advocacy in a Native land context. Both DSJE and NAH feel the campus community would greatly benefit from having such a decorated speaker come to inspire the next generation of environmental activists at our unch and dinner events. Respectively, each event has the goal of developing a community of students and the Champaign community, who are committed to submission activists at our unch and dinner events. Respectively, each event has the goal of developing a community of students and the Champaign community, who are committed to environmental finances, ecological justice, and collective democratic engagement in addressing climate challenges. This work we feel can be best done through the encouragement and unique experiences that Tara Houska has to offer as the fights for climate-environmental justice nationwide. Most notably so when she worked alongside Bernie Sanders as his advisor on Native American affairs. Each event would allow not only for Houska to share her experiences and knowledge on environmental justice through a Native lens by being given opportunities to ask questions and converse with her in the NAH dinner.

Describe how your project addresses sustainability.*



Our projects address sustainability through platforming a decorated tribal land attorney who has dedicated her work to fighting for environmental and climate justice as it pertains to Native peoples. This perspective we see as especially important to the University as we have the responsibility to acknowledge the Native lands we stand on and how we can further honor and take care of them locally and nationally. The campus community has many students already dedicated to environmental awork and connecting them to a pioneer in the field such as Houska herself we feel will empower the campus community even further with the knowledge, skills, and passion to become positive change agents, driving sustainable and equitable environmental soutions in their communities and beyond.

We estimate that at least 80 students will be directly impacted by the project based on information of recent DSJE lunch turnouts. It is likely that 100-130 students will be attending these events in total

How many students will be indirectly impacted by this project? *

By allowing Tara to impart her knowledge and experiences onto us, we can indirectly impact more than just the students who come for her presentation and dinner. For example, many Native students at UIUC plan to use their education to help their own communities. Tara coming for the Encouragement Dinner and aiding Native student success will indirectly benefit all the people who that one student will help as a tribal attorney, physician, etc..

Tara will be both presenting at the DSJE Lunch on Us program and then join the NAH Encouragement Dinner. The presentation will benefit students by giving them an indigenous perspective on land stewardship and climate activism. It will also encourage them to think about how environmental and climate concerns uniquely impact marginalized communities such as Native Americans. The Encouragement Dinner at NAH will be beneficial for students to have a discussion with Tara in a more intimate setting. This would allow students to ask her more specific questions and get answers for concerns more specific to Native students. Her experiences as tribal attorney and defender of tribal land would make her a role model for many students. NAH students learning more about her journey through higher education would also provide encouragement for students just before the oncoming stress of finals.

We hope to promote awareness of social-environmental justice issues and indigenous perspectives on these topics by bringing Tara to UIUC. By encouraging students to come to her presentation by pairing it with Lunch on Us and getting students to see her at NAH at an encouragement dinner, we will get students engaged on these important topics, and being aware of a topic is the first step towards acting on our campus.
