After preliminary testing of some composites and aerodynamics, the optimized geometry of the vehicle has been decided upon. In addition, the presumed required quantities of certain composite materials have been modified to better match this optimized geometry of the new vehicle. We now know that we need more advanced composites components: wood (for ease of storage and transport of our molds), glue, putty, space heaters, oven parts, adhesives, trim tools, and materials for further testing.

Though we have not yet, we are hoping to use our position in time, having just won the Formula Sun Grand Prix this past summer, to secure more sponsored resin and carbon fiber materials, in the case that we can reallocate some of our funding from these sponsor-able materials to instead fund our new focus on composites work, and fund the safety materials needed to work with composites.
