6. All projects will be expected to follow campus policies and procedures as well as any applicable State and Federal laws.
7. SSC reserves the right to revoke funding if the project does not comply with the terms and conditions outlined in this letter.
8. Any press releases or educational/promotional materials involving the project should acknowledge SSC funding.
9. Any signage involving the project or events surrounding this project should include SSC's logo and/or a statement of which fee funded the project. Projects must coordinate with SSC to ensure promotion appropriately highlights the SSC's contributions to the project.

**Project Description:**

Facilities and Services will designate (3) staff (director/professional level and/or grounds staff) to receive the National Green Infrastructure Certification Program (NGICP) training through Parkland College as a pilot to determine future F&S investments in this training for grounds crew and other F&S project staff.

Participants will provide a presentation about program outcomes and any results, lessons, learned and best practices for adoption by F&S landscape crew. F&S staff will determine needs for further funding for Green Infrastructure training in the future.

The NGICP is a program that provides entry level workers the skills needed to properly construct, inspect, and maintain green storm-water infrastructure such as rain gardens, bioswales, green roofs and other green infrastructure involved in the management of campus surface water that's compatible with the conservation of land, resources and biodiverse habitats.

This proposal directly funds:

- Program registration: \$399.00 x 3
- Exam registration: \$150.00 x 3
