- 5. Any substantial modifications to project scope, budget, or timeline must first be approved by SSC. These requests must be submitted in a formal letter to the Chair and Coordinator.
- 6. All projects will be expected to follow campus policies and procedures as well as any applicable State and Federal laws.
- 7. SSC reserves the right to revoke funding if the project does not comply with the terms and conditions outlined in this letter.
- 8. Any press releases or educational/promotional materials involving the project should acknowledge SSC funding.
- 9. Any signage involving the project or events surrounding this project should include SSC's logo and/or a statement of which fee funded the project. Projects must coordinate with SSC to ensure promotion appropriately highlights the SSC's contributions to the project.

Project Description:

Since 1995 University Housing operated a salvage drive as a way for students to donate used furniture, clothing, appliances, canned and boxed foods, and electronics at the end of the semester. In 2012, University Housing started collaborating with the University YMCA to coordinate this effort, and in spring 2019, at the request of Chancellor Jones and the University YMCA Board, University Housing and Facilities & Services contributed drivers and trucks to assist with collections. This year, we are working toward a standing commitment from campus to support Dump and Run and are working with the Office of the Chancellor about potential expansion into the wider community. We are seeking SSC support for the next two years for the basic services campus provides, while a long-term strategy for a community-based program is identified.
