- 5. Any substantial modifications to project scope, budget, or timeline must first be approved by SSC. These requests must be submitted in a formal letter to the Chair and Coordinator.
- 6. All projects will be expected to follow campus policies and procedures as well as any applicable State and Federal laws.
- 7. SSC reserves the right to revoke funding if the project does not comply with the terms and conditions outlined in this letter.
- 8. Any press releases or educational/promotional materials involving the project should acknowledge SSC funding.
- 9. Any signage involving the project or events surrounding this project should include SSC's logo and/or a statement of which fee funded the project. Projects must coordinate with SSC to ensure promotion appropriately highlights the SSC's contributions to the project.
- 10. Funding will not be spent on prize package items that students already own.

You will be notified when the Institute for Sustainability, Energy, and Environment and Vice Chancellor for Student Affairs officially approves this project. Eco-Olympics is a 3-week energy conservation competition between campus residence halls. Our mission is to engage a greater percentage of the student population in establishing energy-conscious habits, by developing a sense of community in addition to offering incentives. We believe in the power of individual efforts. Our concrete goals include: 1) Outreach-get at least 500 students to demonstrate commitment via completion of a survey. 2) Energy reduction-double our reduction from last year as well as increase participation by one third every year of the competition. At the conclusion, we will offer a participation award to the hall with the most participants (a sustainable package prize) and an energy reduction award to the hall with the biggest energy reduction (celebration dinner).
